2. Purpose of the processing:

The photos and/or videos are used exclusively for the public relations work of Wasser 3.0 gGmbH.

3. Legal Basis for Processing:

The processing of photos and/or videos (collection, storage and transfer to third parties (see under 5) is based on the express consent of the person(s) with parental authority or the person(s) concerned, i.e. in accordance with Art. 6 para. 1 letter a GDPR. The publication of selected image files in (print) publications of the organiser/participating partners and on their homepage/social media accounts or similar is necessary for the public relations work of the organiser and thus serves to safeguard the legitimate interests of the participants, Art. 6 para. 1 letter f GDPR.

4. Categories of Recipients of the Personal Data:

The photos and/or videos are passed on to third parties (e.g. cooperation partners and press representatives) for external press and communication work For public relations purposes, they may be posted on the Wasser 3.0 gGmbH homepage and used for Wasser 3.0 gGmbH's social media activities.

5. Duration of Storage of Personal Data:

Photos and/or videos taken for the purposes of Wasser 3.0 gGmbH's public relations work will be stored for an indefinite period of time for a specific purpose, subject to revocation of the consent of the data subject(s).



6. Right to withdraw consent:

Consent to the processing of photos and/or videos can be revoked at any time for the future. The legality of the data processing carried out on the basis of the consent until the revocation is not affected by this.

7. Rights of data subjects:

According to the General Data Protection Regulation, you have the following rights:

- a) If your personal data is processed, you have the right to obtain information about the personal data stored about you. (Art. 15 GDPR)
- b) If incorrect personal data is processed, you have the right to have it amended (Art. 16 GDPR)
- c) If the legal requirements are met, you can request the deletion or restriction of processing and object to the processing (Art. 17, 18, 21 GDPR)
- d) If you have consented to the data processing or a contract for data processing exists and the data processing is carried out using automated procedures, you may have a right to data transferability. (Art. 20 GDPR)

If you make use of the aforementioned rights, the responsible party will check whether the legal requirements for this are met. You also have the right to file a complaint with the State Commissioner for Data Protection of the State of Baden-Württemberg.
